

#### **Before Senior Year**

- Young Adult Readiness Assessment (DCF)
  - Identify and support long and short-term goals
  - Identify continued student support system.
- PAYA (DCF)
  - Life skills necessary to sustain education
- Discuss Post Secondary Education, set goals, and discuss expectations (All adult supports)
- Pre-SAT's and SAT's (All adult supports)



#### Making the Right Decision

- Readiness- Social/Emotional needs
- Academics
- Research colleges and schedule tours
- Costs Return on Investment
- Vocational vs. College
  - Career Assessment Career Centers



#### What is financial aid?

- Money to pay for college or career school.
   Understanding the difference.
- College is NOT for FREE!
  - Grants
  - Loans
    - Federal vs. Private
  - Work-study
  - Scholarships





#### What types of aid can students apply for?

- Federal student aid: fill out Free Application for Federal Student Aid (FAFSA)
- Undocumented residents that qualify as "high school completers" can complete the Massachusetts Application for State Financial Aid (MASFA)
- High School Guidance Office Local Scholarships
- School aid: contact financial aid office at schools you are considering
- DCF Financial Aid



#### FAFSA and MASFA applications

Massachusetts Application for State Financial Aid (MASFA)

- A FAFSA or MASFA must be completed by all foster youth
- Deadlines are even more important for foster youth
- Take advantage of existing resources:
  - **▶DCF Programs**
  - > MEFA
  - FAFSA DAY Massachusetts



#### **Completing applications**

#### FAFSA

- Have your Social Security or Alien Registration Number
- Allow the FAFSA to link to your IRS tax records to complete the application.




#### MAFSA

- Students do not need to have a Social Security, Alien Registration Number, ITIN number, or other assigned number.
- Requires an online application and an affidavit completed with the college

**Orphan:** Select this box if at any time since you turned 13, you had no living parent, even if you are now adopted.

Ward of the Court: Select this box if at any time since you turned 13, you were a dependent or ward of the court, even if you are no longer a dependent or ward of the court today. For federal student aid purposes, someone who is incarcerated is not considered a ward of the court.

**Foster Care:** Select this box if at any time since you turned 13, you were in foster care, even if you are no longer in foster care today. If you are not sure if you were in foster care, check with your state child welfare agency. You can find that agency's contact information at childwelfare.gov/nfcad.

**Emancipation:** Select this box if you can provide a copy of a court's decision that, as of today, you are an emancipated minor. Also select the box if you can provide a copy of a court's decision that you were an emancipated minor immediately before you reached the age of being an adult in your state. The court must be located in your state of legal residence at the time the court's decision was issued. Do not select the box if you are still a minor and the court decision is no longer in effect or the court decision was not in effect at the time you became an adult.

**Legal Guardianship:** The definition of legal guardianship does not include your parents, even if they were appointed by a court to be your guardians. You are also not considered a legal guardian of yourself.

Select this box if you can provide a copy of a court's decision that, as of today, you are in legal guardianship. Also select the box if you can provide a copy of a court's decision that you were in legal guardianship immediately before you reached the age of being an adult in your state. The court must be located in your state of legal residence at the time the court's decision was issued. Do not select the box if you are still a minor and the court decision is no longer in effect or the court decision was not in effect at the time you became an adult. Also leave the box blank and contact your school if custody was awarded by the courts and the court papers say "custody" (not "guardianship").

If you meet any of these conditions, the financial aid administrator at your school may require you to provide proof that you were in foster care, a dependent or ward of the court, an emancipated minor, or in a legal guardianship.

#### **Tuition Equity & MASFA**

#### "High School Completers" Tuition Equity Law

Expanded eligibility for instate tuition rates

Attend a Mass high school for 3+ years AND earned a Mass diploma or equivalent

Meet other documentation requirements

# Massachusetts Application for State Financial Aid (MASFA)

For certain non-US citizen students, including undocumented students

Attend a Mass high school for 3+ years <u>AND</u> earned a Mass diploma or equivalent

#### **Types of DCF Care and Custody**

- Protective Custody
- CRA
- Adoption
- Guardianship Placement
- Voluntary Placement Agreement

Other Types of Possible Independents: **Probate**, Homeless, Runaway, DYS



#### **Documentation for Independents**

#### DCF can assist with:

- Proof of foster care custody status and a Ward of the Court Letter,
- Proof of Guardianship if sponsored by DCF.
- Guardianship documents are also available at the court.



#### After the FAFSA or MASFA

- Verification Process
  - Ward of court/ foster care letter
  - Income verification
  - Independent Status
  - Proof of residency
    - Remind students to read letters and check email!





#### What happens next?

- Students will receive financial aid packages from each college
- Review Financial Aid Packages with students
- Explain the difference between grants and loans.
- Complete yearly health insurance waivers
  - Identify on-campus health centers and counseling centers for additional student support

#### **Tuition & Fee Waiver**

#### **Eligible Youth**

- In DCF Protective Custody until the age of 18
- Unable to return home
- Have not yet turned 25
- Adopted
- Guardianship
- Completed the FAFSA or MASFA

The waiver is for the cost of tuition of only state supported classes at Mass community colleges and universities. *It does not cover books, application fees, or room and board.* 



#### **Foster Child Grant**

#### **Eligible Youth**

- Permanent legal Resident of Mass
- US citizen or non-citizen eligible under Title IV regs.
- DCF care via Care & Protection Petition
- Not yet reached 25<sup>th</sup> Birthday
- Enrolled Full-time (12 credits or equivalent)
- Completed the FAFSA or MASFA
- Meets school's requirements for satisfactory academic progress



#### **Education and Training Voucher**

#### **Eligible Youth**

- Youth who were in DCF custody until age 18.
- Unable to return home
- Eligible until age 26
- Adopted/Guardianship after the age of 16
- Must have High School Diploma or GED
- Completed the FAFSA



#### William E. Warren Scholarship Eligibility

- In DCF custody and out-of-home placement for a minimum of one year
- Under age 25
- Enrolled in a post-secondary Title IV eligible program.
- Demonstrate academic potential and commitment to educational goals
- Demonstrate significant unmet financial need
- Demonstrate ability to overcome challenges and obstacles
- Completed the FAFSA or MASFA



#### William E. Warren Scholarship

- Competitive scholarship; students evaluated on academic merit and financial need
- Granted once a year summer application
- Awards typically between \$500 - \$2,000

- College Connections
  - Financial Aid Staff
  - Student Support Services

  - Housing



## Consider what campus support networks are available.

What services are available for mental health support?

Is there an identified contact in the Financial Aid Office for youth in foster care?

Where can they get tutoring?

Where can they access support available for housing during breaks?

Where can they obtain support around disabilities and accommodations?

Do they have contact information for DCF staff that can assist them with financial aid and other needs?
